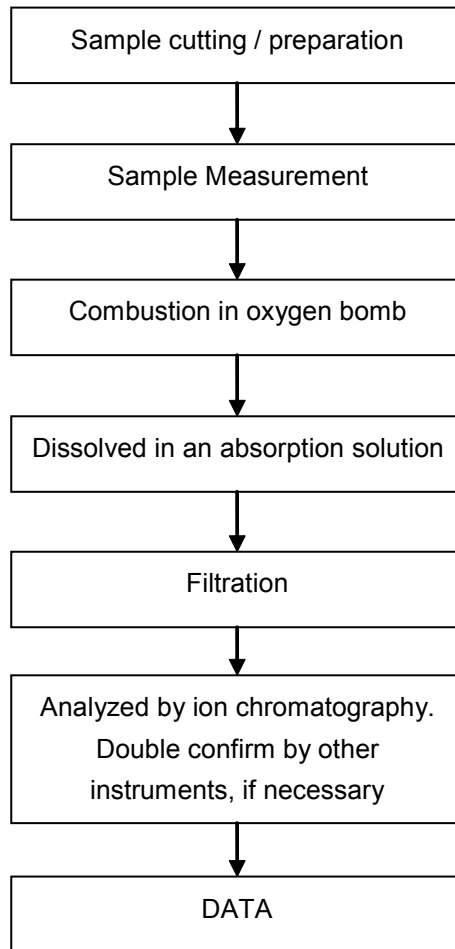

Halogen Testing Flow Chart

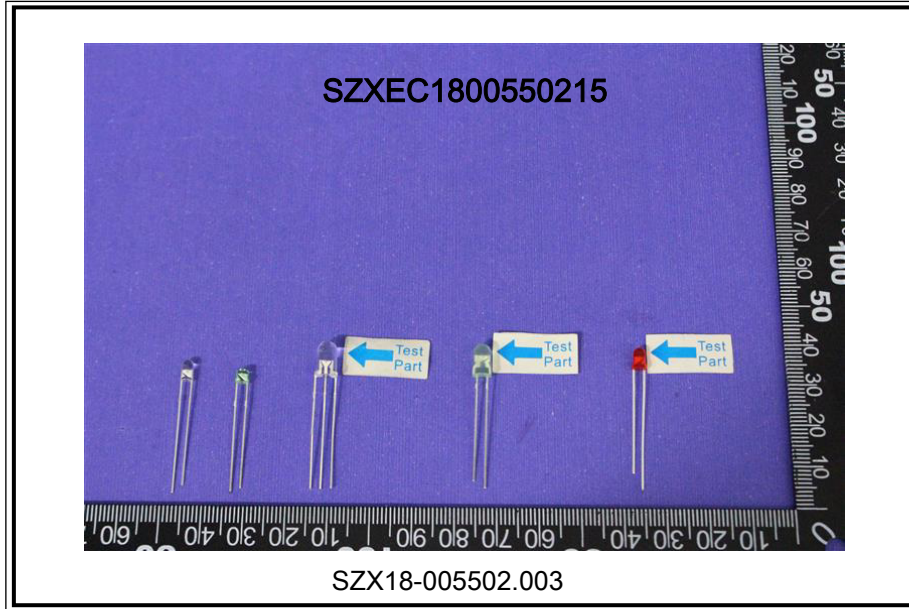
